MINUTES REGULAR MEETING HELOTES CITY COUNCIL

The City of Helotes City Council met for a regular meeting on Thursday, February 26, 2015 at 7:00 p.m. in the City Hall Council Chamber, 12951 Bandera Road, Helotes, Texas. This was an open meeting, subject to the open meeting laws of the State of Texas.

1. Call to Order.

Mayor Schoolcraft called the meeting to order at 7:00 p.m. Council Member Alex Blue led the invocation. Mayor Schoolcraft led the pledge to the U.S. flag and the Texas flag.

ITEMS FOR INDIVIDUAL CONSIDERATION:

6. Presentation by Armstrong, Vaughan, & Associates, P.C. and discussion of and action on the Fiscal Year Ending 2014 Audits for the City of Helotes and the City of Helotes Economic Development Corporation. (Auditor & Staff)

Kim Roach, with Armstrong, Vaughan, & Associates, P.C., presented an overview of the audit findings. Ms. Roach noted that the firm did not have to make recommendations to the City for improvements. Overall, the City earned a clean audit report.

Ms. Roach also noted that new standards regarding pension requirements will not affect the City's day-to-day budgeting process. The Dispatch and EMS department funds have been moved into the General Fund; these departments' budgets will now be noted just like other City departments' budgets. With the inclusion of Dispatch and EMS budgets, the average monthly expenditures in fund balance would drop from 10.5 months to 3.7 months. The 3.7 average monthly expenditures in fund balance is considered to be a good average.

Motion was made by Council Member Blue, second by Council Member Villanueva, to accept the audit report as presented.

Motion to approve carried unanimously.

7. Discussion of and action on a request for a variance to detention / fee-in-lieu-of requirements by the Helotes Festival Association, Inc. from the Municipal Code of Ordinances Chapter 34 Environment, Article IV Stormwater Detention and Drainage for the construction of three (3) separate restroom facilities on property located, generally, at 12210 Leslie Road, Helotes, Texas 78023, more particularly described as CB 4478 P-12B (12.135AC), P-13A (2.053AC), and P-14A (5.923AC) ABS 716, CB 4478 P-11A ABS 716, and CB 4476 P-2B 4.54 AC A-249 CB 4478 P-10 .428 AC A-716 CB 4479 P-2 4.237 AC A-843. Council Member Buys filed a conflict of interest affidavit with the City Secretary's office and abstained from discussion and voting on this item. Council Member Buys serves on the Festival Association Board of Directors.

Motion was made by Council Member Friedrichs, second by Council Member Villanueva, to discuss and act on this item as written.

The City Engineer recommended approval of the variance request due to the limited square footage of each of the three proposed restroom facilities. The HFA property consists, generally, of three tracts of land totaling 44.316 acres. The proposed facilities will be located on a 15.00 acre tract of land located, generally, in the middle of the HFA property.

Mayor Schoolcraft noted that HFA is requesting a variance to detention and a variance to the feein-lieu of payment.

Motion to approve the variance to detention and the variance to the fee-in-lieu of payment carried; 4 Ayes, 0 Nays, 1 Abstain – Council Member Buys.

8. Discussion of and action on a Resolution of the City Council of the City of Helotes, Texas requesting that the Texas Legislature amend Tex. Loc. Gov't. Code §1.005(3) by clarifying the definition of "municipality" to include all types of municipalities within the State of Texas. (Staff)

Motion was made by Mayor Pro Tem Massey, second by Council Member Blue, to discuss and act on this item as written.

9. Discussion of and action on a Resolution of the City Council of the City of Helotes, Texas opposing any municipal revenue cap legislation and interference with local services. (Staff)
